**To either of the Constables of the Town of Chesterfield in the County of Hampshire,**

**GREETING.**

**IN THE NAME OF The Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town qualified to vote in elections and Town affairs, to meet at the Community Center in said Chesterfield on the Tenth day of September next, at 7:00 o'clock in the evening, then and there to act on the following articles:**

**ARTICLE 1:** To see if the Town will vote to transfer \$130,000 from the School Building Maintenance Stabilization Fund to pay Chesterfield's share of the roof replacement at New Hingham Regional Elementary School, and for the payment of all other costs incidental and related thereto; or to take any other action relative thereto.

*Note: The total contract price to replace the roof is \$194,400. Chesterfield's share is \$98,466. This article amount includes contingency moneys as well as \$550 required to create the intergovernmental agreement allowing Chesterfield to pay our share in cash and not to borrow.*

**ARTICLE 2:** To see if the Town will vote to accept an easement on Stage Road to maintain a new drainage area; or to take any other action relative thereto.

**ARTICLE 3:** To see if the Town will vote to accept an easement abutting the Ireland Street Cemetery; or to take any other action relative thereto.

*Note: This is for a 20' easement along the right side of the Ireland Street Cemetery (from the street to the back of cemetery).*

**ARTICLE 4:** To see if the Town will vote to transfer the sum of \$24,000 from Free Cash now in the Treasury to purchase eight (8) new portable radios for the Police Department; or take any other action relative thereto.

*Note: The new radios would be on the same frequency as the MA State Police radios, which the current Department radios are incompatible with.*

**ARTICLE 5:** To take up any other matter which may legally be brought before this meeting.

**And you are hereby directed to serve this Warrant, by posting up attested copies thereof at the Chesterfield Post Office and the Town Office Building in said Town, fourteen days at least before the time of holding said meeting.**

**HEREOF FAIL NOT, and make due return of this Warrant, with your doings thereon, to the Town Clerk, at the time and place of meeting, as aforesaid.**
