Please be advised that there will be a Pole Hearing on Tuesday, January 16, 2024 at 4:45 p.m. The meeting will be held at the Davenport Town Office Building, 422 Main Road.

## **DETAILS:**

Petition for Pole Locations from Verizon New England, Inc. and NSTAR Electric Company dba Eversource

Request permission to locate poles, wires, cables and fixtures, including the necessary anchors, guys, and other such sustaining and protecting fixtures to be owned and used in common by the petitioners, along and across the following public way or ways:

<u>Indian Hollow Road:</u> Relocate one (1) JO (jointly owned) pole numbered T.77/E. 12 to a point on the south side of Indian Hollow Road at a point approximately one hundred seventy eight (178) feet westerly of existing pole T.76/E. 11.

<u>Indian Hollow Road:</u> Place one (1) JO (jointly owned) mid-span pole numbered T.80/E 14M on the northwest side of Indian Hollow Road at a point approximately one hundred sixty-nine (169) feet southwesterly of existing pole T.80/E. 14 and one thousand seventy-three (1,073) feet westerly of the centerline of South Street.

<u>Indian Hollow Road:</u> Place one (1) JO (jointly owned) mid-span pole numbered T.81M/E 15M on the northwest side of Indian Hollow Road at a point approximately one hundred and sixty-nine (169) feet westerly of existing pole T.81/E 15; and one hundred sixty-nine (169 feet northerly of existing pole T.82/E 16.

<u>Indian Hollow Road:</u> Place one (1) JO (jointly owned) mid-span pole numbered T.82M/E 16M on the southeast side of Indian Hollow Road at a point approximately one hundred sixty-nine (169) feet southwesterly of existing pole T.82/E 16 and one hundred and sixty-six (166) feet northeasterly of existing pole T.83/E 17.

<u>Indian Hollow Road</u>: Place one (1) JO (jointly owned) mid-span pole numbered T.83M/E.17M on the southeast side of Indian Hollow Road at a point approximately ninety-seven (97) feet southwesterly of existing pole T.83/E.17 and one hundred and ninety-five (195) feet northeasterly of existing pole T.84/E.18.

<u>Indian Hollow Road</u>: Place one (1) JO (jointly owned) mid-span pole numbered T.85M/E.18M on the southeast side of Indian Hollow Road at a point approximately one hundred thirty-six (136) feet southwesterly of existing pole T.84/E.18 and one hundred (100) feet northeasterly of existing pole T.90/E.19.

<u>Indian Hollow Road</u>: Place one (1) JO (jointly owned) mid-span pole numbered T.90M/E.19M, on the southeasterly side of Indian Hollow Road at a point approximately one hundred (100) feet southwesterly of existing pole T.90/E.19; and one hundred forty-seven (147) feet northeasterly of existing pole T.91/E.20.

<u>Reason</u>: Eversource has initiated this request to support the existing pole line; and to provide for the distribution of intelligence and telecommunications and the transmission of high and low voltage electric current. Poles to be erected substantially in accordance with the plan filed herewith marked-Verizon No. **1A5V8EV**, dated November 14, 2023

Also for permission to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as said petitioners may desire for distributing purposes.
