

- I participate in the Food Bank's Brown Bag Program;
- I live alone and my income is below \$29,160; or,
- The total income of my household is below \$39,440 (only one share per household please).

# Self-described 'fighter' seeks access for handicapped

Karen O'Neill cannot get inside the post office to collect her own mail. She cannot get inside the Town Hall to vote or participate at a Town Meeting. She cannot get inside the Town Office to see the Town Clerk or Tax Collector. She is unable to attend programs at

he he to to or. at

her child's school, or to check a book out of the library, or to attend a community meeting at the church or Grange Hall. And even if she were to get inside, restroom facilities would be impossible for her to use.

Curbs, narrow doors and stairways block all of these activities to Ms. O'Neill because she is a paraplegic restricted to a wheelchair.

Ms. O'Neil, 26, and her children Jessie, 8, and Todd, 4, moved to a farmhouse in Chesterfield in August. Soon after she moved to town, Ms. O'Neill contacted local officials advising them of her need and her right to enter public buildings. Her request comes at a time when federal mandates are also demanding communities end discrimination against the handicapped by making their buildings and services accessible to all.

Paralyzed from the neck down at age 15 from a diving accident in her family's Springfield backyard pool, Ms. O'Neill says she has learned to be a "fighter." Seeing that this town makes its services accessible to her and to other handicapped individuals is one more hurdle that she is determined to surmount. Following her accident, she was hospitalized for an entire year, kept alive by a respirator with a broken neck and back and a permanently damaged spinal cord.

"I spent two whole years totally dependent on others. I could have let go and died so many times. But I'm a fighter. My first words after the accident were, 'Thank God I'm alive,'" Ms. O'Neill recalled, the emotional trauma still very evident in her voice.

Mr. O'Neill endured a series of operations and several near-fatal bouts of pneumonia. Through hard physical therapy, a strict diet and sheer willpower she recovered to the point that she was able to return to high school for her senior year. But the only classroom that was accessible to her in the building was her English class and if she had to use the bathroom, she had to go home. Eight years later, Ms. O'Neill has had two children through natural childbirth, attended college classes in music and holistic health, recorded her own original musical compositions and learned to drive.

"Before I learned to drive, I stayed home all the time and so did my kids," she explained. Her therapy now includes swimming, exercises, a macrobiotic diet and singing, which strengthens her damaged lungs. Music, she says is also a creative and emotional release and she plans to someday make it her profession. She has a battery-powered wheelchair and drives a van equipped with a lift. Yet these mechanical aids still place severe restrictions on her freedom.

As a parent, Ms. O'Neill explained she is even more strongly motivated to gain access to community live because "what restricts me also restricts my children's freedom." Ms. O'Neill and her family are still living out of cardboard boxes while their two-story house undergoes extensive renovations. A ramp and a staircase chair slide have been installed. Doors have been widened to accommodate her wheelchair. She will have a custom-built shower that she can get in and out of without assistance. The entire kitchen must also be rebuilt with lowered counters and accessible cabinets.

Following her contact with town officials, Ms. O'Neill was offered the position of handicapped coordinator by the selectmen. But Ms. O'Neill has declined the position, saying that her priority right now is getting settled in her own house and that it is the town's responsibility and not hers, to see that the law is applied. "Right now, I can't even get into my own shower. I've already given so much of my time," she explained. "Right now, I have to concentrate on my kids' and my own needs."

Once she is able to, O'Neill says she looks forward to participating in community life and "giving her energy to others." She plans to volunteer at the local elementary school, as she did in Amherst, because she believes that it is important for children to feel comfortable around handicapped people.

"So many people are afraid of the handicapped, I'll honestly answer any question a child asks," she remarked.

# **Caregivers Part 2: Banking**

More thoughts on keeping your care recipient financially safe. Last month was credit cards, now we give attention to banking.

Again, this is all easier if you have a robust durable Power of Attorney (POA) that allows banking functions. With this, you can talk to bank officials, go online to check deposits and balances, make deposits and withdrawals, balance the checkbook, and request the settings below. Different banks have different policies, so check with your particular bank on the specifics but this should give you good questions to ask. For instance, even without a POA the bank might allow you to monitor another person's bank statement, after clearing you.

<u>Create alerts.</u> Get a message from the bank when a withdrawal goes over a set amount, or a balance falls lower than you want. You may also be able to get an email every day showing the available balance on the account.

**<u>Set transaction limits.</u>** If a withdrawal is requested that goes over a set amount, the transaction can be halted.

**Stop payment.** If something does go awry, you can request that the bank stop the payment.

<u>Check overdraft status.</u> Banks offer protection against the account going into the red, but you should choose how or if you want that protection. This is a not one-size-fits-all decision.

Help Wanted: Part Two

Finding home care help in the hilltowns can be a challenge. There's a shortage of available workers and Medicare certified home care agencies often can't fill requests for help. Many of us rely on family and friends or programs through our senior center which may work for short term solutions, but what if you anticipate needing help for an extended period of time? Did you know that there are programs that let you hire your own worker? That worker can be a family member or friend (not spouse).

MassHealth has two different programs that pay family caregivers for the care they provide. You must requirements financial eligibility MassHealth. Many folks assume they "won't be eligible because I have money in the bank". But there are ways to qualify and you should check with your SHINE counselor. Income has to be less than \$2,742/month with limited assets. But, you can transfer assets without a 5 year look back period if you are intending to remain at home instead of entering a nursing home. Also, for those of you who are not going to qualify for MassHealth, Highland Valley has a program called "self-directed care" which allows you to hire your own worker. If you are a veteran, you might qualify for some home care help. And while It's less common, if you are one of those folks with a Long Term Care Insurance policy, that policy will also pay for home care help. Need help sorting through all the options? Check with your senior center and ask to speak to the SHINE counselor.
