Question 1

Shall the Town of Chesterfield adopt the following zoning by-law?

Summary: Massachusetts General Laws, Chapter 94G, Section 3, allows a town, through adoption of a by-law and approval of a ballot question at a Town election, to prohibit the operation of one or more types of marijuana establishments in the Town. The Zoning By-law amendment set forth below, which was approved by the vote of the March 26, 2024 Special Town Meeting, would prohibit all types of marijuana establishments in the Town except "Marijuana Retailers," as the relevant terms are defined in G.L. c. 94G, § 1, 935 CMR 500, 935 CMR 501, and Section 6.4.3 of the Zoning By-law as amended by the vote of the March 26, 2024 Special Town Meeting.

Text of Zoning Bylaw:

To amend Section 3.0 ("Table 1 Schedule of Use Regulations") of the Town of Chesterfield Zoning By-Law, by deleting the text in strikethrough and inserting the text that is bold and underlined, as set forth below,
